### History

Established in 1997 as the "Emmaus Foundation, Inc.", doing business as "The Catholic Foundation of the Diocese of Saint Petersburg", the foundation serves the people and ministries of the Diocese of Saint Petersburg. We support the work of Christ in the Diocese by receiving gifts and working with donors on long-term funding solutions.

Since its inception in 1997, the Catholic Foundation remained dedicated to accepting and protecting legacy funds as well as raise annual funds to support the work of Christ in the Diocese. Some of the annual fundraising efforts caused some confusion with donors as they supplemented a current operating ministry within the Pastoral Center funded through the annual fundraising efforts of the Diocese.

In pastoral year 2023-2024, the Board entered into conversations with Bishop Gregory Parkes and diocesan leadership to more clearly define the mission and purpose of the foundation. Diocesan staff would be responsible for raising funds under the auspices of the Diocesan offices of Stewardship & Development, while the Foundation would remain focused on accepting, protecting and governing legacy funds created by donors, parishes, schools and ministries. The Foundation also will serve as the gift acceptance and governance agent for annual funds raised by the diocese. This realigned focus became effective on July 1, 2024.

### **Not-for-Profit Status**

The Catholic Foundation is incorporated as the Emmaus Foundation, Inc., dba The Catholic Foundation, Diocese of Saint Petersburg under article

501(c)(3) of the Internal Revenue Service code as a not-for-profit charitable entity.

The Catholic Foundation fulfills its mission in partnership with special individuals and organizations who entrust their legacy gifts to our care. Those who benefit from established legacy funds as well as our Catholic Foundation staff and Board of Trustees are fully aware the entities we support can accomplish more thanks to the bi-annual distributions from their long-term funds.

Acknowledging our most generous donors is a priority for Bishop Parkes. He does this, in part, through the Mater Dei Giving Society. Named in honor of our Blessed Mother, the Mater Dei Giving Society recognizes more than 5,500 members helping our diocese put our faith into action so the world can see who we are by the good works we do in Christ's name.

Each year, members receive special mailings, opportunities to share their prayer intentions with Bishop Parkes, as well as invitations to in-person events. "The reason you are here today is because you have done and continue to do good things for the Lord," shared Bishop Parkes at the prayer service held for giving society members at the Cathedral of St. Jude the Apostle on November 19, 2023. Three of the four circles of our Mater Dei Giving Society include Catholic Foundation donors.

### **Inspirational Care**




While she was resident of Island Estates and a parishioner of St. Brendan Parish in Clearwater for 25 years, a generous benefactor gave a life-transforming bequest that made the St. John XXIII Residence possible. Charlotte Schmidt Rhodes was a nurse, a widow and a devoted Catholic, she died in June 2021.

In August 2021, Bishop Parkes was informed the Diocese was named a beneficiary in Charlotte's estate. Rhodes wanted the Diocese to use her gift to build a retirement home for diocesan priests, nuns, and needy or disabled elderly Catholics.

In her bequest, Charlotte provided a timeframe in which the project had to reach groundbreaking. By partnering with Angels Senior Living, the St. John XXIII Residence was blessed and dedicated on October 19, 2022. The assisted living facility is comprised of 22 studio, one and two-bedroom accommodations with kitchenette, living room, and views of nearby woods. They share a chapel for the celebration of daily Mass, praying of the Rosary, weekly adoration, spiritual devotions, and Bible study. A Pastoral Services Coordinator attends to the continued spiritual growth and development of the residents. In addition, there is a citation of scripture on the floor in every room, religious artwork lines the halls, and the sunroom features religious statues.

"There is a story told, which I've not been able to confirm, that she was quite concerned for Msgr. Edward Mulligan who was the founding pastor of Saint Brendan's and was having difficulty finding a place to live after he retired," shared Rev. Msgr. Michael Muhr, appointed by Bishop Parkes to lead the St. John XXIII Residence initiative. "This may have been her inspiration."

Thank you for Courageously Living the Gospel and for leaving the Diocese of Saint Petersburg, its ministries and missions in your will.



### A Family Legacy Fulfilled

Many years ago, St. Mary Our Lady of Grace Parish in St. Petersburg received a bequest from the Fiedler Trust, a long-time parish family. The bequest noted the intent to create an endowment for the parish, however, the amount of the bequest did not meet the fund establishment amount.

The leadership of the parish placed the bequest into a separate savings account, and let it grow over time safely. In 2024, Rev. Damian Amantia, TOR, and the parish finance council contacted the Catholic Foundation to utilize the Fiedler bequest to establish the Saint Mary Our Lady of Grace Endowment Fund.

The bequest from the Fiedler family is now a living legacy through the foundation's endowment program, investing the establishing donation and providing support for the parish through the investment earnings. As with many other endowments, those wishing to become a part of this legacy of generosity may also donate to the fund through a direct gift or through their estate as the Fiedlers did.



### **Bequests: Wills and Trusts**

A bequest is made in the donor's Will or Revocable Trust. The donor can direct that a specific dollar amount, certain assets, a percentage of the donor's estate or trust or the remainder of the donor's estate or trust (after all other distributions have been made) can be gifted to any entity, parish, school, or ministry of the Diocese.

One-time last gifts through wills and trusts should be directed to the Diocese. As a corporate sole, it is vital to use the correct wording in estate documents. The correct bequest language is as follows: All bequests and estate documents to create a perpetual or endowed fund for the Diocese, its ministries or entities should be directed to the Catholic Foundation of the Diocese of Saint Petersburg.

### FOUNDATION LEGACY FUNDS

Throughout its history, the Catholic Foundation remained dedicated to accepting and protecting legacy funds as well as raise annual funds to support the work of Christ in the Diocese. In pastoral year 2023-2024, the Board entered into conversations with Bishop Gregory Parkes and diocesan leadership to more clearly define the mission and purpose of the foundation. Diocesan staff would be responsible for raising funds under the auspices of the Diocesan Office of Stewardship & Development, while the Foundation would focus on accepting, protecting and governing legacy funds and serve as the gift acceptance and governance agent for annual funds raised by the Diocese.

### **Charitable Gift Annuities**

A charitable gift annuity (CGA) is a type of planned gift that allows a donor to receive fixed payments from an amount of invested principal throughout their lifetime and leave the remainder to a Catholic parish or ministry, or a not-for-profit outreach entity of their choice upon their passing. The Catholic Foundation is licensed to accept and administer CGAs, and currently holds 34 CGA contracts totaling \$1.4 million for 26 beneficiaries.


#### **Donor-Advised Funds**

Since November 1, 2020, the Catholic Foundation has offered our donor-advised fund, allowing donors to give to one not-for-profit (the foundation) and then make grants to multiple not-for-profit organizations over multiple years while receiving immediate tax benefits.

### **Endowments**

Endowed funds established through the Catholic Foundation ensure that the corpus of the donation is preserved, while income earned on the investment is available for use each year for the beneficiary. They are excellent vehicles for donors wishing to provide long-term support for parishes, schools and larger diocesan ministries, especially in the areas of building upkeep and future repairs, ongoing funding for major programs or outreach efforts, tuition assistance, scholarships and much more.





# Community Impact Grant Program

The Community Impact Grant Program was created by the Catholic Foundation Board of Trustees in 2023. All parishes, schools, missions and any recognized ministries of the Diocese of Saint Petersburg may apply. Awards ranging from \$500 to \$5,000 are made to programs that support the diocesan mission of Courageously Living the Gospel by falling into one or more of the following categories:

- Serving Christ by Serving Others
- Youth & Young Adult Initiatives
- Evangelization & Missionary Discipleship

The Community Impact Grant Program was funded through direct donations to the end of the year Giving Challenge as well as the #GivingTuesday effort.

### **Performance and Fund Growth**


Since 2016, the total invested and managed in endowments and long-term managed funds has grown from \$31 to almost \$113 million, an increase of almost \$82 million. This increase can be attributed to both an increase in the number/amount of funds held as well as healthy performance overall. The performance chart to the right shows the steady rate of increase in our portfolio with decreases attributed to global market fluctuations in reaction to the pandemic and recent political and economic volatility.





#### **Distributions**

It is vital to keep in mind that the purpose of endowed and long-term investments is provide ongoing support in perpetuity. This includes years in which investments may be down. This provides a source of dependable support for beneficiaries.

This pastoral year, \$4.2 million was distributed to support the work of larger ministry, parishes and schools. With the sound investment oversight and guidance of our Board and additional increases in the number of funds under management, the Catholic Foundation looks forward to growing that amount in the future.
